# Nifty Rollover Analysis

- 1. The rollover for Nifty Futures advances as **24%** positions got rolled over to the March series as on **D-3** days prior to expiry.
- 2. The current rollovers are lower compare with its three months average of **28%** respectively observed at the same point prior to expiry.
- 3. The rollover cost for long rollovers closed at **28 bps**.
- 4. The total open interest in Nifty Futures across all contracts stands at **12.57Mn** shares.
- 5. The Market wide February expiry rollover is at 36% on D-3 as compared to **26%** on same day of previous expiry.

## **Banknifty Rollover Analysis**

- 6. The BankNifty February expiry rollover is higher at **32%** on **D-3** compared with **21%** on same day of previous expiry.
- 7. BankNifty Futures OI stands at **2.26mn** shares as against the OI of **2.10mn** shares on **D-3** of the last series.
- 8. The rollover cost for long rollovers closed at **39 bps**.
- 9. The current rollovers in BankNifty is higher as compare with its three months average of **27%** respectively observed at the same point prior to expiry.






