Nifty Rollover Analysis

- 1. The rollover for Nifty Futures advances as **29%** positions got rolled over to the November series as on **D-3** days prior to expiry.
- 2. The current rollovers are higher compare with its three months average of 28% respectively observed at the same point prior to expiry.
- 3. The rollover cost for long rollovers closed at **22 bps**.
- 4. The total open interest in Nifty Futures across all contracts stands at **12.87Mn** shares.
- 5. The Market wide October expiry rollover is at **38%** on **D-3** as compared to **38%** on same day of previous expiry.


- 6. The BankNifty October expiry rollover is higher at **32%** on **D-3** compared with **26%** on same day of previous expiry.
- 7. BankNifty Futures OI stands at **2.06mn** shares as against the OI of **1.91mn** shares on **D-3** of the last series.
- 8. The rollover cost for long rollovers closed at **30 bps**.
- 9. The current rollovers in BankNifty is higher as compare with its three months average of **30%** respectively observed at the same point prior to expiry.


