Nifty Rollover Analysis


- The rollover for Nifty Futures advances as 32% positions got rolled over to the January series as on D-3 days prior to expiry.
- 2. The current rollovers are higher compare with its three months average of **28%** respectively observed at the same point prior to expiry.
- 3. The rollover cost for long rollovers closed at **28 bps**.
- 4. The total open interest in Nifty Futures across all contracts stands at **12.36Mn** shares.
- 5. The Market wide December expiry rollover is at **37%** on **D-3** as compared to **37%** on same day of previous expiry.


Banknifty Rollover Analysis

- 6. The BankNifty December expiry rollover is higher at **30%** on **D-3** compared with **28%** on same day of previous expiry.
- 7. BankNifty Futures OI stands at **2.85mn** shares as against the OI of **2.72mn** shares on **D-3** of the last series.
- 8. The rollover cost for long rollovers closed at **43 bps**.
- 9. The current rollovers in BankNifty is higher as compare with its three months average of **29%** respectively observed at the same point prior to expiry.


