- 3. The rollover cost for long rollovers closed at **47** bps.
- The total open interest in Nifty Futures across all contracts stands at 13.73Mn shares.
- 5. The Market wide January expiry rollover is at **74%** on **D-1** as compared to **78%** on same day of previous expiry.


- 6. The BankNifty January expiry rollover is lower at 62% on D-1 compared with 69% on same day of previous expiry.

- The current rollover in BankNifty is in line as compare with its three months average of **62%** respectively observed at the same point prior to expiry.


