


Nifty Rollover Analysis

- The rollover for Nifty Futures advances as 36% positions got rolled over to the February series as on D-2 days prior to expiry.
- 2. The current rollover is lower as compare with its three months average of **40%** respectively observed at the same point prior to expiry.
- 3. The rollover cost for long rollovers closed at 44 bps.
- 4. The total open interest in Nifty Futures across all contracts stands at **13.73Mn** shares.
- 5. The Market wide January expiry rollover is at **54%** on **D-2** as compared to **59%** on same day of previous expiry.



Banknifty Rollover Analysis

- The BankNifty January expiry rollover is lower at 48% on D compared with 54% on same day of previous expiry.
- 7. BankNifty Futures OI stands at **2.44mn** shares as against the OI of **2.68mn** shares on **D-2** of the last series.
- 8. The rollover cost for long rollovers closed at **44** bps.
- The current rollover in BankNifty is higher as compare with its three months average of 45% respectively observed at the same point prior to expiry.


