
# **ROLLOVER SNAPSHOT (D-2)**


### Nifty Rollover Analysis

- 1. The rollover for Nifty Futures advances as **44%** positions got rolled over to the April series as on **D-2** days prior to expiry.
- 2. The current rollover is higher as compare with its three months average of **43%** respectively observed at the same point prior to expiry.
- 3. The rollover cost for long rollovers closed at **45 bps.**
- 4. The total open interest in Nifty Futures across all contracts stands at **16.91Mn** shares.
- 5. The Market wide March expiry rollover is at **55%** on **D-2** as compared to **60%** on same day of previous expiry.



## **Banknifty Rollover Analysis**

- 6. The BankNifty March expiry rollover is higher at **67%** on **D-2** compared with **41%** on same day of previous expiry.
- 7. BankNifty Futures OI stands at **5.90mn** shares as against the OI of **3.23mn** shares on **D-2** of the last series.
- 8. The rollover cost for long rollovers closed at **61** bps.
- The current rollover in BankNifty is higher as compare with its three months average of 47% respectively observed at the same point prior to expiry.


