

## Nifty Rollover Analysis


- The rollover for Nifty Futures advances as 66% positions got rolled over to the August series as on D-1 days prior to expiry.
- 2. The current rollover is higher as compare with its three months average of **57%** respectively observed at the same point prior to expiry.
- 3. The rollover cost for long rollovers closed at **59** bps.
- 4. The total open interest in Nifty Futures across all contracts stands at **14.38Mn** shares.
- 5. The Market wide July expiry rollover is at **77%** on **D-1** as compared to **76%** on same day of previous expiry.



- 6. The BankNifty July expiry rollover is higher at **60%** on **D-1** compared with **55%** on same day of previous expiry.
- 7. BankNifty Futures OI stands at **2.86mn** shares as against the OI of **3.14mn** shares on **D-1** of the last series.
- 8. The rollover cost for long rollovers closed at **41** bps.
- The current rollover in BankNifty is higher as compare with its three months average of 57% respectively observed at the same point prior to expiry.


